New & Improved Features

The following are new features in Minerva Solution 12.0.2

Export All function

From Tag Book collections, Tag Book views in projects, and Tag Book views on parts, it is possible to export all files from the deliverables in the containing projects (files attached to deliverable document items, and documents attached deliverable part items). The Export package is created as a zip.file with the same structure as the Tag Book.

New instantiation modes for deliverable

The instantiation mode 'Instantiate' is replaced by the Instantiation mode 'Instantiate By Project'. A new Instantiation mode 'Instantiate By Phase' has been added. With 'Instantiate By Phase' the deliverable line is automatically instantiated when its phase is activated.

Closing rule 'By Target Property'

The closing rule 'By Target Status' has been replaced by the new closing rule 'By Target Property'. The deliverable line isn't closed until the state of the deliverable reaches the selected 'Target Value' of a selected 'Target Property'. For each deliverable, you can select which Target Property (e.g. the property 'current_status') and Target Value (e.g. the value 'Released' for the property 'current_status') should close this deliverable line.

Technical File Tag Book

During installation, it is possible to also add the Tag Book 'Technical File'. The Technical File will then be present in all the same places as the DHF and DMR are by default (on projects, as templates, as the view on parts, as Tag Book collections)

Information on deliverable regarding template

On items that are deliverables created from a template, a link to the template is displayed on the item form.

System Settings added

System Settings (Minerva Smart Rules) have been added. The System settings can be changed by users with a

Deliverable Instantiation behavior

By default when a deliverable is instantiated, the latest version of the deliverable template is used. But it is possible to change the setup so that instead of the latest version, the deliverable will be instantiated from the latest released version of the deliverable template.

Release project template with unreleased deliverables

By default, it is possible to release a project template (promote to state 'Approved') if it contains deliverable templates that are not in a released state. It is possible to change the setup, so that it is either not allowed or that a warning appears when you try to promote.

Release part with unreleased risk assessment

By default, it is possible to release parts that have an unreleased risk assessment. This can be changed by a system setting. It is possible to change the setup, so that it is either not allowed or that a warning appears when you try to release the part.

List of Risk Assessments

In the Navigation Panel, it is possible to find a list of all parts with Risk Assessment added

Fixed Issues

The following issues have been fixed in this version:

Issue no.	Description
MS-1309	Now a warning appears, if you on a phase, try to add an end date that is earlier than the start date
MS-1311	Copy relationships from the template when the deliverable is instantiated
MS-1222	On a Risk Decrease Change, it was not possible to add new Recommendations and Controls after the mitigation of Harms to Controls
MS-1126	Problem with Refresh in certain circumstances on projects/deliverables
MS-887	Couldn't go to the next line using the 'Tab' key, when creating a new Severity

Known Issues

The following issue is known in this version:

MS-911	The error message "The grid is too small" could appear, when you opened the "Risk" tab on a part. Work around: press the 'Refresh' icon
MS-1361	Problem with deliverables with instantiation mode 'Instantiation By Phase', if added to a pending phase after the project is started. (The deliverable is not instantiated when the phase is activated).
